The key for SEX is as follows:

- 1 = Male
- 2 = Female

The key for ORIGIN is as follows:

The key for RACE is as follows:

- 1 = White Alone
- 2 = Black or African American Alone
- 3 = American Indian or Alaska Native Alone
- 4 = Asian Alone
- 5 = Native Hawaiian and Other Pacific Islander Alone
- 6 = Two or more races

AGE is single-year of age (0, 1, 2,... 84, 85+ years).

Notes: Vintage 2023 data products are associated with Data Management System projects P-6000042, P-7501659, and P-7527355. The U.S. Census Bureau reviewed these data products for unauthorized disclosure of confidential information and approved the disclosure avoidance practices applied to this release (CBDRB-FY24-0085).

The estimates are developed from a base that integrates the 2020 Census, Vintage 2020 estimates, and 2020 Demographic Analysis estimates. The estimates add births to, subtract deaths from, and add net migration to the April 1, 2020 estimates base. Race data in the Vintage 2023 estimates do not currently reflect the results of the 2020 Census. Hispanic origin is considered an ethnicity, not a race. Hispanics may be of any race. Responses of “Some Other Race” from the decennial census are modified to be consistent with the race categories that appear in our input data. This contributes to differences between the population for specific race categories shown and those published from the 2020 Census.
